Enclosed is information related to the 100-150 Hrs PART C Pastoral Medicine Core Competency Certification . As per the Statutes and Regulations of the American Association of Integrative & Pastoral Medicine(aka IPMA), all practitioners are required to successfully complete Part 3 of the IPMLEX as a condition to maintaining Licensure...This is Mandatory. No exceptions.

The Course will be available for the 2015 Licensure year and must be completed by Dec 31st. 2015... However If you have not enrolled, you may enroll and pay the fee for enrollment and also your annual licensure fee in order to continue to have an active Licensure for the 2016 year.

We cannot provide any more grace period, as all practitioners licensed on or before Dec 31st. 2014 had able opportunity to enroll in the mandatory course. Thus enrollement must occur by Dec 20th. All Licensure renewals will be issued in Mid January. Those of you who became licensed in the middle of the year, should have Licensures and Board Certifications with the renewal date for Dec 31st 2016. Thus you are only required to pay the renewal fee's and will not need to be issued new Licensures and Board Certifications.

All licensee's have the option of paying in full for the IPMLEX PART C Course or making a Down payment and 4 additional Payments. All payments must be made via Paypal., as due to changes in operations and to ensure no payments are lost in the mail, we will be moving to electronic communications. You will still recieve Hard Copies of your Licensures and Board Certifications.

If you are a practitioner whose been sanctioned and fined, please note you are required to pay for all fines and fee's. Failure to pay any fines or fee's that are owed may be turned over to a collection Agency and placed on your credit report. If you hold any State license, we also reserve the right to report such to your State Licensing Board. Any license or registrations that are expired, are not renewed, are revoked or suspended for any reason, is required to be returned along with the Board Certifications to the AAIPM. Failure to do so will result in fines that could stack up per day, week or month until such licensures and Certifications are returned, as they are the property of the AAIPM. Practitioner can choose to destroy such certifications and dispose of them and pay a 350.00 severance fee per each of the License and Board Certifications

As per the strict rules and regulations of the AAIPM, under federal authorized mandate and as per our by laws and statutes that are legally binding perpetually, any practitioner whose license is no longer active or is revoked or suspended for any reason CAN NOT practice any form of Integrative and/or Pastoral Medicine or any semblance of such under any other license, board certification, Un-authorized organization, entity or religious institution. This does not apply to any state licensed or registered occupational professions.

AAIPM is the only legally authorized Licensing board that regulates the occupational Profession of Integrative and/or Pastoral Medicine. The Violation of any of our codes, by laws and Certification Marks, Trade Marks and Licensing authority will result in heavy fines and

prosecution to the fullest extent of the law. As per our policy, we are required to do mandatory reporting of any practitioner who was subjected to licensure revocations, suspensions or expirations, except in cases of retirement, who yet willfully continues to engage in the practice of holistic healthcare, religious healthcare, integrative medicine, pastoral medicine or any semblance of pastoral medicine which is regulated under the rules, codes and bylaws of the AAIPM or in any other manner that purports to circumvent AAIPM Pastoral Medical Licensures, to the State Medical Board of the respective State in which such violator resides and/or operates. This will result in investigation and prosecution of practice "medicine" without a license, as no religious license issues by any other entity will quality for coverage to protect such practitioner from prosecution for practicing medicine without a license. If violator is a state licensed practitioner, then such report will be made to the respective licensing board which will result in sanctions as determined by such board. Any legal proceedings or litigation that may occur due to such violations will result in the violator paying all of the legal and attorneys fee's of the American Association of Integrative and Pastoral Medicine as per the Laws, codes and policies of AAIPM.

This past year our Licensing Board has experienced some significant setbacks, which is very dissappointing but which is due to the fraudulent bogus activity and behavior of other religious boards mis-using and abusing our Certification Marks and Trade Marks and bringing a bad name to the profession of Pastoral Medicine, as they hide behind PO Box's and swindle hundreds of practitioners out of their money.

Furthermore they have poorly educated practitioners with little to no evidence based healthcare training, or clinical skills who are given bogus credentials with practically no standards whatsoever to get such credentials and then these practitioners go out and swindle patients/clients out of their money while offering severely poor quality healthcareservices under the guise of pastoral medicine, which has resulted in many patients being harmed or having to deal with life threatening issues due to malpractice of these practitioners.

This in turn causes patients, who have been victimized, to become confused in thinking our Association is the same as the one with the frauds due to similarities in the names of each Association. We have had hundreds of phone calls and emails from countless patients calling in to complain about mistreatment, fraud, being given bogus MLM supplements which made their condition worse, or simply never recieving the services they paid thousands of dollars for or having bogus diagnosstic performed on themm, only for us to have to explain that those practitioners are not licensued nor recognized by us and that they are a fraud...

Furthermore we have had to deal with practitioners being caught trying to secretly join the other group, resulting in us having to discipline quite a few and levy heavy fines for doing soo. Some practitioners in fact ended up having their practices Raided by law enforcement for not adhering to the Rules, By Laws and Statutes AAIPM and not taking our Licensing Authority seriously.
